








2019 HALL OF FAME







HUD Secretary Carson Expresses Strong Support for Manufactured Housing at Congressional Hearing

The morning after HUD announced that it was rescinding its 2017 carport letters, Secretary Carson appeared before the House Financial Services Committee and reaffirmed his strong support for manufactured housing. Secretary Carson testified that "manufactured housing is a critical part" of the affordable housing solution.

Representative Andy Barr (R-KY), who authored the original amendment to rescind the carport letters that passed the House unanimously in September 2017, thanked the Secretary for finally rescinding the letters. Barr said that the "policy imposed a costly and time-consuming hurdle for the production of manufactured homes that negatively impacted consumers and forced many manufacturers to stop offering these carport-ready homes."

Representative Barr went on to point out that there is more work to be done, noting that "HUD still has not finalized more than 100 recommendations by the Manufactured Housing Consensus Committee, some going back a decade." Barr specifically asked Secretary Carson what can be done to "change the internal processes at HUD so that more of these recommendations are more promptly adopted." Secretary Carson told Representative Barr that he is working on "beefing up the division [Office of Manufactured Housing Programs] so that they are not just treading water" and commented that "they [the Office of Manufactured Housing Programs] are really making forward progress right now."

In response to a question from Representative Scott Tipton (R-CO) about the lack of affordable housing in rural America, Secretary Carson reiterated that manufactured housing is a major source of homeownership in rural areas and said that "anything we [HUD] can to do enhance the

manufactured housing industry is going to be helpful for the situation in rural areas."

During an exchange with Secretary Carson, Representative John Rose (R-TN), stated that manufactured housing is an integral part of the housing landscape in his state. Secretary Carson agreed with Representative Rose's statement and expressed the importance of "concentrating on modernizing our building techniques and integrating those into our housing policy."

comments at the hearing manufactured housing are the culmination of MHI's effective advocacy efforts, including sustained engagement with the Administration, HUD and Congress. MHI has made expediting changes to the HUD Code a top priority. MHI is the only trade association representing the industry in Washington whose actions have resulted in an improved regulatory climate for manufactured housing at HUD and excellent support on Capitol Hill. During his address at MHI's Congress and Expo in New Orleans, Secretary Carson acknowledged MHI's efforts, stating "I am grateful for the many insights MHI has provided to HUD in the form of its available reports, educational materials, and constructive dialogue."

MHI will continue its productive and effective advocacy to change HUD's approach to regulating manufactured housing and to ensure timely updates to the HUD Code to support the efficient production of high-quality homes with features consumers want at affordable prices.

In March 2019, 7,623 new manufactured homes were shipped, a decrease of 1,190 homes or 13.5 percent compared to March 2018. Compared with the same month last year, shipments of single-section homes were down 18.2 percent and shipments of multi-section homes were down 9.2 percent. Total floors shipped in March 2019 were 11,859, a decrease of 12.1 percent compared with March 2018.

The seasonally adjusted annual rate (SAAR) of shipments was 90,459 in March 2019, down 1.9 percent from the adjusted rate of 92,195 in February 2019. The SAAR corrects for normal seasonal variations and projects annual shipments based on the current monthly total.

The number of plants reporting production in March 2019 was 134 and the number of active corporations was 34, the same number of plants and active corporations as in February 2019.

Cumulative shipments from January through March this year totaled 22,357 homes compared with 25,520 homes for the first quarter of 2018, a net decrease of 12.4 percent.



Senator William Thad Cochran

The past few days, Mississippi has said goodbye to a great leader, United States Senator Thad Cochran (December 7, 1937-May 30, 2019). On behalf of MMHA, I attended the ceremony at the State Capital and the funeral at Northminister Baptist Church. Not many powerful leaders are known by their first name only, but our Senator was and his name was Thad. Thad was known on the Hill as the gentle persuader and at the funeral, Senator Leahy called him the Senators' Senator. He was loved and respected by all who knew him because everyone knew that Thad Cochran loved his Mississippi. As Senate appropriation chairman, he made sure that funds were directed to Mississippi to help meet our needs. After Katrina devastated our gulf coast, he worked both sides of the aisle to bring billions of dollars to rebuild not only Mississippi's gulf coast but the whole south region. Senator Richard Shelby noted in his remarks at the funeral how Thad helped rebuild the entire gulf coast. Each and every time, I and other MMHA members met with Thad and his staff on issues affecting manufactured housing, he always came through. His word was all we needed to know our request would be honored. It was his language in the appropriation's bill for many years that prevented our industry from being under the DOE regulations. Thad worked for the betterment of all Mississippians, but he also helped all Americans with many of the bills that he authored and supported during his 45 years of service at the U. S. Capitol. Thad was the 10th longest serving U. S. Senator in the history of the Senate. I along with MMHA members have memories of sitting with Thad in his office in Washington listening to his stories and even getting to hear him play his baby grand piano. Thad was a dear friend of mine and Dick and we will always be grateful for his friendship. I will cherish my memories, treasure our friendship, and thank God for giving Mississippi such a gentle giant as our U. S. Senator. Rest in peace, Thad.
